## Medicaid Pathway Work Group: MH/SAT/DS Scope as of April 11, 2016

## **Objective of Reform**

Develop an organized delivery system for serving individuals with specialized health service needs and promote integration of:

- > Physical Health
- > Mental Health
- Substance Abuse Treatment
- > Long-Term Services and Supports for individuals with developmental service needs
- > Long-Term Services and Supports for individuals with physical disabilities and older Vermonters
- > The organized delivery system will support:
  - Vermont's Model of Care
  - > Payment Reform, including value based purchasing
  - Service Delivery Reform, including population-based health and prevention, quality improvement and development of best practices
  - > Medicaid's Pathway for the All-Payer Model
  - Efficient operations and oversight

## Considerations: Programs and Services to Include in Reform Planning for MH/SAT/DS

- > Inclusion in the near term versus phased in over long term
- > Extent to which delivery system is organized to:
  - Support adoption of Model of Care, including advancement of integrated care
  - Engage in service delivery reform
  - Create a pathway to All-Payer Model
- Medicaid is primary payer for service
- > Program currently adopts some or all elements of the model of care
- Broad inclusion of program may be more desirable in promoting comprehensive System of Care approach (prevention to intervention)
- > Specialized programs need to be considered but should not be sole focus of planning efforts
